- 1. Health insurance plan for Central Valley Trust JPA.
- 2. Dental insurance through Delta Dental Service (regular dental care for self and dependents)
- 3. Benefits plans described above in 1., 2., and 3., are chosen by the Classified Management Unit, the District paid portion is \$1,150.00 per month for medical, dental and vision from July 1, 2006.
- As of July 1, 2007 the District will no longer pay a longevity incentive. Effective July 1, 2007 all step increments will increase by 5%, consistant with past practice.
- 5. The Plant Manager salary schedule was revised as of 3/8/2012. This was due to the hiring of a new Plant Manager and the need for a full range of steps.
- 6. Vacation time: based on time worked with district
 - less than 3 years 12 dy/yr (1.0000 dy/mo worked)
 - 3-7 years 17 dy/yr (1.4167 dy/mo worked)
 - 8-10 years 22 dy/yr (1.8333 dy/mo worked)
 - 11-15 years 27 dy/yr (2.2500 dy/mo worked)
 - 16 years and over 32 dy/yr (2.6667 dy/mo worked)
- 7. Extended health care for retired employees, 55 years or older, who have completed 8 years of continuous district service. The district will cover 50% of the district paid insurance cap for health, prescription, dental and vision. These medical benefits will remain in effect until the employee qualifies for Medicare a maximum of 12 years, whichever comes first.
- Holidays The following are to be paid holidays: New Year's Eve, New Year's Day, Martin Luther King Jr. Day, Lincoln's Day, Presidents' Day, Memorial Day, Juneteenth, Independence Day, Labor Day, Veterans' Day, day before Thanksgiving (in lieu of Admission Day), Thanksgiving Day, day following Thanksgiving, Christmas Eve, Christmas Day. Floating holiday (to be used within regular duty days, not accruable)
- 9. As of February 21, 2006, the Holidays were changed to include Christmas Eve and New Year's Eve. This change in holidays, is effective as of July 1, 2005.
- 10. Effective July 1, 2012 Entire schedule was increased 1.58%
- 11. Effective July 1, 2013 Entire schedule was increased 3.0%
- 12. Effective July 1, 2014 Entire schedule was increased 4.5%
- 13. Effective July 1, 2015 Entire schedule was increased 2.91%
- 14. Effective July 1, 2016 Entire schedule was increased 4.91%
- 15. Effective July 1, 2017 Entire schedule was increased 2.34%
- 16. Effective July 1, 2020 Eliminated Steps 23 & 28 and Revised Vacation Accrual Years
- 17. Effective July 1, 2020 Entire schedule was increased 3.0%
- 18. Effective July 1, 2021 Entire schedule was increased 5.0%
- 19. Effective July 1, 2022 Entire schedule was increased 6.56%
- 20. Effective July 1, 2023 Entire schedule was increased 6.0%
- 21. Effective July 1, 2024 Entire schedule was increased 3.0%. Adjusted longevity steps.
